6. The show committee will read the publication, "Dealing With Misconduct" prior to our show and be prepared to sit on the bench hearing panel if necessary.

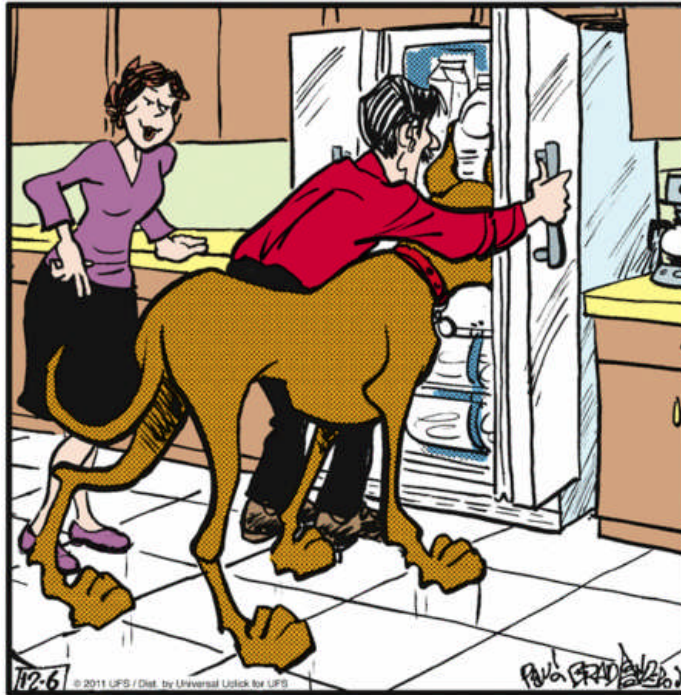
