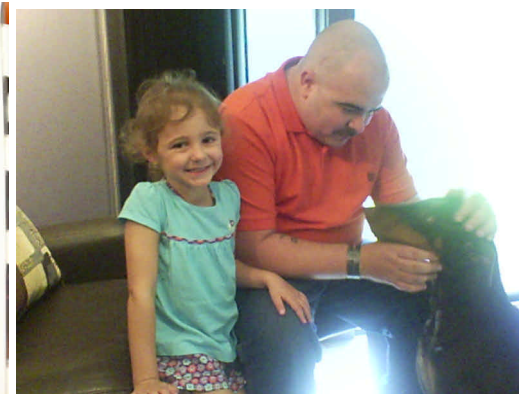
Old Business
