From I-75, take exit 205 Hwy 16 west toward Griffin. Turn left on 8<sup>th</sup> St.

From Hwy 19/41, take Hwy 16 exit east, then turn right on 8<sup>th</sup> St.

Turn right at Spalding Hospital (Graefe St), at stop sign turn left

Keep straight after entering the park. Pavilions are bordered by Public Golf Course.
